A Short History

- Istanbul 2001: "Meeting the Challenge"
 - Global meeting calls for "collective action by, among and between ... partners"
- 2003: Supply Initiative
 - NGO consortium formed to call attention to RH supply shortages, mobilize new resources, increase their efficient use for RH supplies
- 2003: Task Team
 - Informal core group organized to identify global-level solutions to increase efficiencies on financing supplies, systems.
 - Supply Initiative provides secretariat support
- 2004: Reproductive Health Supplies Coalition (RHSC)
 - Task team evolves into a broader coalition, with expanded membership, scope
 - Secretariat supported through Supply Initiative

RHSC: The Basics

- Forum for global leadership to increase access to RH supplies by promoting a more coordinated and structured response to:
 - Inadequate and unreliable financing
 - Inefficiencies and volatilities in systems
 - Inequities in access
- Members share a common vision:
 - Improve global health and quality of life by ensuring access to high-quality RH supplies
- 21 member organizations

How Does the RHSC Operate?

- Meets twice yearly (2006 New York/UNFPA, Frankfurt/KfW)
- Three working groups are technical "engines"
 - Resource Mobilization and Awareness
 - Systems Strengthening
 - Market Development Approaches
- Secretariat, Executive Committee, Chair (2006-08 Germany & The Netherlands)
- Terms of Reference adopted October 2005
- 2006 Full time Secretariat and Director, located in Brussels
- Next priorities: membership, communications, monitoring and evaluation, business plan

What Does the RHSC Do?

- Synthesize and share information, knowledge, and experience
 - Map existing experience, evidence, lessons learned relating to private sector market development approaches
- Improve coordination and harmonization of programs
 - Develop consistent advocacy messages for funding RH supplies
 - Countries-at-Risk group
- Provide joint advice & monitoring for development, use of common tools and approaches
 - RH Interchange (http://rhi.rhsupplies.org)

Technical Priorities of the RHSC

- Market development approaches
 - Synthesize, share knowledge about "total market" approaches
 - Develop, test, validate models for commercial markets that serve lower income consumers
 - Promote supportive environments for provision of RH supplies by private sector
- Systems strengthening
 - Improve use of standardized data to align financing, supply flows with program needs
 - Develop solutions for increased reliability, efficiency of financing
 - Identify, support supply chain improvements
- Resource mobilization and awareness
 - Create an environment conducive to political support for RH supplies
 - Secure increased financial resources
