





Infant Mortality Rate in Major States of India





Unmet Need for FP in UP





Institutional Deliveries in Uttar Pradesh






Public and private expenditure on health in major states : 2001-02



Situation Analysis: Sum Up

- UP has the highest MMR in the country
- IMR is the third highest in the country
- Modern FP method is low
- Use of institutional facilities for deliveries is low
- Use of FP methods and institutional facilities for deliveries is the lowest among poor
- Per capita expenditure of UP govt. on health is very low
- Out of pocket expenditure on RCH services in both government and private facilities is high
- Health care systems places enormous burden on poor

Voucher System in 7 Blocks of Agra Voucher system helps to purchase outputs while also offering beneficiaries a choice of provider.

Agra Voucher System: Objectives

- Target BPL population
- Improve service coverage and enhance demand
- Improve quality of services
- Accredit private health facilities to provide services to BPL families
- Provide a choice of service providers
- Create and manage a voucher system for availing predetermined RCH services
- Establish linkages with other stakeholders




- ANC-3 visits (ANC check up, TT Injection, IFA tablets, Nutrition advice)
- Deliveries (Normal and complicated)
- PNC (2 check ups, breast feeding counseling and FP counseling)
- Family Planning (Sterilization, IUCD, Condoms and Pills)
- Child Immunization (free of cost—supplies from CMO)
- RTI/STI (check ups, treatment, partner counseling)

Agra Voucher System: Cost of Services

Cost of services are at least 35-50 percent less than prevailing market prices

ANC check up	Rs 25 per visit
Normal delivery	Rs 1,500 inclusive of medicines, one day hospital stay and pediatrician visit
Caesarian delivery	Rs 5,000 inclusive of medicines, anesthetist charges, 5/6 days hospitalization, pediatrician visit
PNC	Rs 25 per visit
FP Services	Rs 1,500 per sterilization and Rs 100 per IUCD


Activities Completed for Establishing the System

- Preparation of quality std. guidelines for private nursing homes
- Assessment and accreditation of private nursing homes
- Contractual agreements with nursing homes and Medical College
- Design and printing of vouchers with holographic stickers and serial numbers
- Preparation of monitoring records and reports
- Preparation of referral slips, discharge slips and case sheet formats

Activities Completed for Establishing the System

- Basic IEC material for clients
- Preparation of a list of ASHA in each subcentre
- Orientation programs to ASHA, ANMs and supervisors
- Distribution of vouchers to ASHA
- Design of monitoring systems
