



# HANSHEP Health Enterprise Fund Expo Video Transcript

## Introduction: Context in Kenya/Ethiopia

**USAID Representative** - Barbara Hughes, Director, Office of Population and Health, USAID/Kenya

One of the ways to encourage sustainability in a health system is to engage the private sector. Our theory is that if you take the people who could afford to get their care in the private sector out of the public sector then it allows the resources available for the people who won't ever really be able to afford the private sector to be better focused and targeted and take some of the burden off of the government. The flip side has to be that the private sector has to be able to offer care that is affordable and quality. We're very interested in encouraging dialogue between investment organizations and entrepreneurs, the cross-fertilization between entrepreneurs.

**USAID Representative** – Bedan Gichanga, Health Systems Specialist, USAID/Kenya There's a lot of innovation in this country but the problem with that innovation is that it doesn't meet capital. A lot of the innovation that has been happening has died because there was nothing to nurture it. There was no capital flow to it. If you look at the banking sector here, it has been very reluctant to put money to the health sector.

The main goal of the Health Enterprise Fund is to identify innovative enterprises that may not quite be ready for investment but that show promise, show opportunity and with the right kind of capital injection through the grants we're providing, with the right kind of technical assistance, we can take those enterprises to a point where they're more ready for investment.

So what the challenge fund I think will help do is allow that space between the innovators and capital to meet and eventually, from that, we can get investments.

The SHOPS project seeks to increase the role of the private sector in health service delivery.
